 - a. **Mahaska County— G29 West PCC Overlay TIP 47195-G29** from US63 to 260 feet West of Hickory Ave. This project needs to be added to the TIP/STIP. PCC Overlay project, distance 3.4 miles. The amount of the project will be \$400,000 from state funds, local match \$2,600,000, and the total project of \$3,000,000. Amendment revisions are required when adding a new project to the STIP/TIP FFY 2026
 - b. **10-15 Transit—TIP 12074 Van Replacement—**This is an amendment to add new federal aid project from FFY25 to FFY26. Federal Funding from 5339. Other federal funds will increase from \$73,189 to \$91,970. Local match from \$12,916 to \$16,230. Total project cost will increase from \$86,105 to \$108,200.
